#### **Update from Jane Howson: VCSE representative on the D2N2 Board**

## **ESIF Programme Updates**

### **D2N2 Community Programme: Active Inclusion Grants Programme call REOPENED**

A reminder that the Department for Work & Pensions announced the reopening of the call for the D2N2 Active Inclusion Grants Programme. This call is for managing agent(s) to manage the grants programme across the D2N2 area. The deadline for applications is **20<sup>th</sup> August 2018**. Please note this is now a single stage application process only.

This call has been reopened pending clarification of issues raised in relation to defrayal that may have prejudiced against some potential applicants. Full details of the call and links to additional background information can be found here:

## **ESFA Programme Extensions**

On Wednesday 23rd of May 2018 LEPs were informed that the ESFA can extend their ESF opt-in arrangements to support the delivery of programmes from April 2019. The extension of opt-in arrangements will allow the ESF programme to utilise match funding from the ESFA and draw down additional ESF resources which would otherwise have to be found by applicant organisations through open call.

The ESFA will provide match funding and by doing so will be allocated a proportion of LEP ESF resources to pay for administering the programmes. The ESFA will allocate funding to secure provision using its own processes and will monitor the performance of the activity it is funding. Currently D2N2 have the following programmes being delivered by ESFA opt in arrangements

- a) Investment Priority 2.1 - SKILLS Local
- b) Investment Priority 1.1 - EMPLOY Local
- c) Investment Priority 1.2 - CAREERS Local and D2N1 Youth Engagement.

All the above projects are due to end in March 2019.

The ESFA have issued the following timelines for LEPs who wish to take advantage of the offer

1. ESFA issue Expression of Interest to LEPs with response required by 13 June 2018
2. ESFA issue conflict of interest / ethical walls protocols - response required by 13 June
3. Specifications development with LEPs – 18 June to 6 July 2018
4. Launch of Invitations to Tender – 31 July 2018
5. Contracts negotiated with successful applicants from January 2019
6. Delivery commences April 2019. Contracts will run from April 2019 to March 2021 with option to extend to 2023 based upon agreement with ESIF committee

As part of this process the ESFA have also indicated willingness to begin discussions around co-financing arrangements for the second half of the ESF programme. All negotiations in relation to this are currently being coordinated by Richard Kirkland, D2N2 ESIF Coordinator.

## **Other Opt-in updates**

Both DWP and Big Lottery Fund are currently investigating opportunities for project extensions in time; utilising underspend in Inspire LOCAL (DWP) and the 3 Building Better Opportunities programmes across D2N2.

Although extensions are welcome to maximise use of the available ESF in D2N2, they also make planning for the second half of the programme (and analysis of committed funding and results) more

difficult. As a result the D2N2 officer team are working closely with all opt in providers to ensure a full understanding of current and future commitment against LEP targets and objectives.

Big Lottery Fund are considering their options as a co-financer of ESF in the second half of the programme. A report and recommendation is likely to be presented to the England Committee in September 2018. A letter summarising this was sent to ESIF Sub Committees in June and can be viewed [here](#).

## **Other News**

### **Workplace Mental Health**

Business leaders have seen a rise in the number of staff raising concerns around mental health in the past 14 months, [a survey by the Institute of Directors revealed](#). The poll of 700 directors showed four in ten have been approached by staff, up 12 percentage points from 2017. A similar number (42%) report employees taking time off work due to mental health problems.
