Consultation on neighbourhood planning regulations

The Department for Communities and Local Government has opened a consultation on the proposed new planning powers giving communities the ability to shape the character of their neighbourhood.

Under the neighbourhood planning regulations, communities will have a voice in deciding the look and feel of development in their area, including the location of new homes, the design of buildings, the shops they want in their high street, and the green spaces that should be protected. The new powers being will also give local people the power to decide the types of development that can be granted automatic planning permission, through a Neighbourhood Development Order.

The regulations include how a neighbourhood area will be defined, how to set up the forums that will propose plans, and outlines the requirements for establishing a Neighbourhood Development Order. The regulations draw on existing procedures where possible to minimise the time communities and councils need to become familiar with the new system.

New £20million Social Action Fund

The Social Investment Business are managing the new £20million Social Action Fund on behalf of the Office for Civil Society. The fund aims to inspire organisations to create new social action opportunities through people giving what they have. The fund aims to support social action in three areas:

- Social action in the community projects that will encourage people to come together in their neighbourhoods to support each other.
- Social action inspired by the Olympics and Paralympics projects that will capitalise on the momentum and enthusiasm generated by the London 2012 Olympic and Paralympics Games to create a legacy of social action.
- Social action for all ages projects that motivate people across all generations to get involved in volunteering and charitable giving – from school children and students, to working professionals and those near or of retirement age.

The fund is open for applications from civil society organisations, public sector bodies and businesses with a track record of delivering social action programmes. Organisations must have operated for more than two years and have a minimum turnover of £100,000.

Power for communities to bring empty houses back into use

Communities Minister Andrew Stunell has announced that community groups will be able to apply for Government funding to bring empty homes that blight neighbourhoods back into use.

VCS organisations will be able to bid for part of £100million Government funding for pioneering housing schemes, which will ensure that the 700,000 empty homes across the country are lived in and provide affordable housing. Formal bidding guidance will be published shortly on how the VCS can apply for financial support to tackle empty homes. Previously only conventional housing providers could apply for this.

The Government will also shortly publish its approach to tackling empty homes, as part of its wider Housing Strategy. This will include consulting on plans to allow councils local discretion to introduce a council tax premium on homes that have been empty for more than two years.

Your Square Mile launches volunteer public liability insurance

Your Square Mile, which aims to encourage members of the public to take part in community activities, has launched a new mutual organisation offering public liability insurance to

volunteers. The mutual charges members £10 a year, which provides them with public liability insurance worth up to £1million for incidents that take place while they are volunteering. It will also offer a legal services helpline for people involved in community work.

The organisation has been set up by Paul Twivy, Former Chief Executive of the Big Society Network, who advised the previous government and current governments on community

The modules have been developed specifically for the VCS and are suitable for groups and organisations of any size, as well as individual staff and volunteers. On completion of each module a certificate can be printed.

Trainee Community Organiser vacancies at Saffron Resource Centre

The Saffron Resource Centre in Leicester, one of the first organisations in the East Midlands to be chosen as a host for the new Community Organiser programme, is recruiting for three Trainee Community Organisers. The positions are for 51 weeks and the hours are 30-35 hours per week full-time (preferably) or 15-17.5 hours per week part-time (possible). The salary is £8.50 per hour, subject to tax and national insurance deductions.

The successful applicants will help residents, groups, associations and businesses in the Saffron, Eyres Monsell and Aylestone Wards to develop their collective power to act together for the common good, by using 'Root Solution - Listening Matters', a dialogue and action-based programme that supports transformational change. It is essential that applicants have good listening and organisational skills, and that they have the desire to learn and develop tools and approaches for animating, developing and catalysing community action.

The Saffron Resource Centre's role as host will be to provide the Community Organisers with office facilities, local support and management, and a learning environment, but they will work independently of the centre, employed by Locality who are delivering the national contract for Community Organisers.

The closing date for applications is Tuesday 1 November. Interviews are expected to be held during the following week and candidates must be available to attend a three-day residential training course from 7 to 9 December.
