Chair's report

The period 2009/10 was a time of consolidation and strategic realignment, ably led by our CEO Rachel Ouinn and her team. The main areas of development relate to a strategic staff review in the summer, arising from changes to our funding streams and the development of new strategic work programmes; and the review and development of our Mem and Arts to reflect a more simple and democratic process. The main changes to the Mem and Arts were the move to a maximum board of 16 with 25% of members being representatives of BME focussed organisations and the option to co-opt board members with specific skills. The co-option route also allowed us more flexibility in filling the BME places, should we found ourselves with fewer than our target of 25%. The changes to our Mem and Arts were ratified at an eam in September. At the same time OEM staff were successful in a bid for Capacity Builders funding that helped us to develop a programme of BME focussed policy work.

The Board governance was further strengthened by the development of terms of reference for the Cabinet, a sub-group of the main board that meets bi-monthly, supporting the CEO and her team and reporting back to the full board, which also now meets bi-monthly. This approach has allowed board members to be as involved in supporting the organisation as their time allows, whilst also

ensuring that the CEO has the opportunity to discuss key items with board members on a regular basis. A special mention goes to Will Wakefield our Treasurer, who has helped to review the accounting systems and support the OEM staff to improve the financial information available to the board. This has improved the board oversight of finances and helped the OEM staff to develop robust financial systems.

Towards the end of the year the CEO and board drafted a new strategic plan for the period 2010-13 that identified four key strategic aims; Influencing; Enabling; Communicating; and Strengthening. This document has underpinned all our work since and has been used to great effect in driving our delivery plan. All of these changes led to a renewed and positive relationship with emda and to continued support from GOEM.

Despite the continued choppy waters OEM, led by our CEO and staff team, has managed to deliver consistently high quality services that have been greatly appreciated by our members. I would like to thank all the staff and board members for their dedication and ongoing support and I hope that the future will provide us with the opportunity to continue to deliver our much needed services.

Chief Executive's report

I am delighted to provide my personal view of the achievements made by One East Midlands during 2009/10; my first year as Chief Executive.

When first joining One EM in late 2008 there was much work to do in re-gaining a strategic purpose that had eroded during a prolonged period of uncertainty. However, in 2009/10 and with the support of a dynamic Board and a talented and progressive team we delivered our promise of

'getting voices heard, shaping change.'

Consultation with our members and stakeholders refined our understanding of One EMs role and resulted in a clear statement of direction by year end.

Following requests from members at the 2009 AGM we also undertook a membership survey. The survey showed that 85% of members felt benefit from our work with information functions and the opportunities to share and network being the most valued. Our aim for 2010/11 is to improve on our services further; aiming to deliver tangible benefits to every member.

So how has this translated into what we do? One EM has mapped and is now working with a wider range of both specialist and generic networks across the East Midlands, linking together those with share

interests to increase voice and influence. We have advocated the role of the VCS loudly, especially in the area of economic impact, and improved our communications approach to ensure that the East Midlands VCS is as informed and current as anywhere in the country.

We have provided support for the VCS to have internal debates on issues such as the role of the sector in personalisation. We have then provided opportunity to take relationships with and reach then used the Partnership events and our links with statutory partners and public sector organisations

And for the future.....well there are more questions than answers at this time but we commit to put our members first and focus delivery on meeting their influencing needs.

In 2010/11 we are already shifting our work to meet your changing demands. Keeping members informed of frequent policy changes, providing opportunities to share learning from one another and supporting the growth of stronger working relationships with local public sector are all key priorities.

The culmination of our focus is to ensure that the voice of individual communities, issues and cultures are not being lost. We will continue to work with local, regional and national colleagues to reinforce those messages and secure the VCS position for the future.

About

One East Midlands is the regional network for the Voluntary and Community Sector (VCS) in the East Midlands region.

Our role is to ensure that all elements of the VCS play a valued role in the development of policies and strategies that impact on the individuals and communities in our region. In particular, we prioritise our support to those parts of the VCS with specialist perspectives and knowledge or working with those communities facing most disadvantage. This role is encapsulated in our mission statement:

'Maximise the role of the VCS as an influential, valued and equal partner in all policy development.'

One EM is a membership organisation and our members set our purpose and strategic direction. We have four core strategic functions that enable us to deliver our mission:

- 1. Influencing Creating an environment for the VCS to exert strategic influence through developing strategic links, shaping policy and advocating the role of the VCS.
- 2. Enabling Developing the sector 'landscape' to enable and support collaboration, develop consensus and raise collective voice through supporting networks and sector representatives,

- facilitate wider 'third sector' collaboration and levering resources
- 3. Communicating Ensuring greater understanding through effective communication, including website and e-bulletin services, magazines and promoting the sector and our members
- 4. Strengthening Supporting the development of the sector through training, sharing best practice and supporting collaboration, events and networking opportunities

How does One EM work in practice?

One EM works closely with a wide range of third sector specialist networks across the region. Our role is to understand the membership, priorities and linkages for each of these networks and ensure that opportunities for them to deliver against these priorities are made available. This role is carried out through four types of activity:

- 1. Developing strategic links and creating opportunities for the East Midlands VCS to represent and embed issues and concerns at the regional level, advocating for specialist representation on key regional skills bodies.
- 2. Working closely with regional VCS and wider third sector networks to understand both specialist and generic sub-sector priorities.

- 3. Linking regional and local networks with other specialist networks where there are shared objectives to increase voice and influence and reduce deep inequality in the region
- 4. Informing the VCS on general policy and strategic developments at the regional level and coordinating VCS perspectives.

One EM directly facilitates some, but not all of these networks. Where we do not directly facilitate networks, we will work collaboratively to ensure strong links and shared understanding. One EM provides direct facilitation support to networks which are cross specialism (e.g. drawing together members from several different networks to achieve a shared objective), which meet an identified gap at regional level or have been identified as a development priority by our members. Whether networks are One EM or sector led, they must all have the following characteristics:

- Member led, with democratic mechanisms for governance arrangements
- Accountable to members and stakeholders
- Open to further membership by organisations with similar aims and objectives

Policy

One EM welcomed Michele Payne, Development Manager, and Henry Muchiyani, Policy Analyst to the policy team in 09/10. During the year, mapping work was carried out on the regional policy landscape, which identified areas for future policy and development work.

Policy work continued in the following fields, with responsibility divided up between members of the senior management team:

- BME
- Children, young people and families
- Communities
- Compact
- Environment
- Equalities
- Funding and income
- · Health and social care
- Infrastructure
- Learning, skills and employability
- Local authority relationships
- Regional economic and spatial development
- Social inclusion
- VCS development
- Volunteering

However, the main policy focus during the 12 month period were BME, volunteering, health and social care, and social inclusion.

BME

Extensive research and relationship building activities were undertaken to support the future launch of the Regional BME Network for the East Midlands. The scope, function, framework and preferred membership of the network were determined through consultation and mapping, with key community leaders committing to support the developing network. The marketing and promotional materials for the network were developed through both desk-based and consultation research, and the priority areas for future activity were identified. One EM also contributed a regional briefing on Ethnic and Cultural Diversity drivers as part of the NCVO Foresight programme.

England Volunteering Development Council (EVDC) East Midlands

EVDC East Midlands was re-launched at The Volunteering Partnership Conference hosted by One East Midlands in September 2009. Presentations and workshops were delivered by a range of speakers (from Age Concern, Office of Third Sector, GOEM, Leicester City Council). Following the conference, EVDC East Midlands was revitalised with the following priorities:

- develop EVDC as strategic coordinated body for East Midlands
- coordinate regional activity on volunteering
- promote volunteering

The East Midlands EVDC network has over 100 member organsisations, including volunteer centres, volunteer involving organisations and volunteer support groups. The steering group consists of 12 members, with One East Midlands providing secretariat support. The first meeting took place in December 2009 and an independent Chair was elected in March 2010 (Al Bell, Community Matters). One East Midlands was commissioned by Volunteering England to undertake a piece of research: 'Mapping Support for People Managing Volunteers Work'; this work was coordinated with support from EVDC members in February 2010.

Health and Social Care

A region wide health network and policy forum was developed with its launch and first meeting, facilitated by consultants Skyers-Poorman, showing strong support and need for the network. A health and social care network steering group was also set up with the key aims of developing the business case for future investment and partnerships with statutory bodies for the improvement of health inequality issues. Following this, One EM's partnership event in February and the Spring issue of Insight magazine focused on health and social care. These ran alongside a series of meetings addressing barriers to successful commissioning both within the health network and health commissioning units. The year ended with the Department of Health eager to ensure an ongoing strategic relationship with One EM, who tendered for delivery of a programme of activity focusing on reach and inclusion.

Social Inclusion

The first meetings of the Social Inclusion Policy Forum, in conjunction with CEFET, took place in 2009 in preparation for 2010; the European Year for Combating Poverty and Social Exclusion. The forum led development of a joint funding submission, between One EM, CEFET, European Anti Poverty Network (EAPN) England and the East Midlands Financial Inclusion Champions. The project aims to raise awareness, challenge myths and develop a legacy under the European Year 2010 banner to combat poverty in the region. The Department of Work and Pensions approved this funding with One EM as accountable body and CEFET as project lead. As part of the NCVO foresight programme, One EM produced a regional briefing on Poverty and Inclusion drivers and responded to the draft Local Economic Assessment guidance consultation published by Communities and Local Government (CLG).

Communications

Online

Alongside the One EM website, which received 2,000+ visits per month in 09/10, the communications team continued to produce fortnightly news and training e-bulletins and a monthly policy e-bulletin. This work was boosted by a grant of nearly £10,000 from the Capacitybuilders Capital Investment Programme to develop online resources and meeting facilities in the region.

In print

Three issues of Insight magazine were published throughout the year accompanying the partnership events and focusing on surviving and thriving, volunteering, and health and social care.

Membership

09/10 saw One EM's membership, which is open to any sector organisation that shares our values, increase to 309 (133 full members, 129 affiliate members and 47 friends). The first year of the membership scheme was celebrated by an anniversary brochure, containing four examples of good practice. This coincided with a membership

survey seeking views on events and information and policy services.

Case Studies

One EM was contracted by Regional Infrastructure Consortium (RIC) and East Midlands Infrastructures Steering Group (EMISG) to produce two video case studies showcasing the impact of infrastructure at a regional and local level. Produced by AMTV, the films featured Northampton Volunteer Centre, Zimwomen, South Derbyshire CVS and Ticknall Lunch Club. The videos can be viewed at

Networking, representation and third sector development

East Midlands Regional Infrastructure Consortium (EMRIC)

EMRIC appointed Gordon Hunter (CEO of Lincolnshire Community Foundation) as their new independent chair and secured a Capacitybuilders' funded awarded a modernisation project to identify and pilot joint working opportunities. Their collaboration programme identified and launched three projects focusing on commissioning, identifying and using effective tools to develop sector organisations to become contract or funding ready.

East Midlands Infrastructure Steering Group (EMISG)

EMISG members undertook campaigning activity with regional MPs and potential future candidates to gain their perspectives on the sector and attitudes to infrastructure.

Joint Working

EMRIC and EMISG pooled some of their marketing budget to develop a series of case studies identifying the impact of infrastructure at a regional and local level (see opposite for details). The case study videos can be viewed at www.oneeastmidlands.org.uk/casestudies. The year ended with EMRIC and EMISG jointly supporting a paper on the development of the Local Area Agreements policy forum.

Timeline

Apr 09: Chief Executive Rachel Quinn joins the East Midlands Economic Cabinet as a representative from the third sector.

May 09: EMRIC awarded modernisation project to identify and pilot joint working opportunities.

Jun 09: One EM approached by CapacityBuilders to identify three frontline groups who might benefit from targeted funding for successful campaign activity. One EM supports Addressing Worklessness in the Region event.

Jul 09: Rachel Quinn confirmed as new member of the East Midlands Regional Assembly. EMISG undertake canvassing of MPs and PPCs on their perspectives of the VCS and infrastructure. One EM supports BEAM (BME Alliance for the East Midlands) event.

Aug 09: Joint tender submitted by One EM to EHRC to develop participation in sport for minority and disadvantaged groups.

Sep 09: One EM Partnership Conference on Volunteering successfully takes place on 9 September. Social Inclusion Policy Forum event held in conjunction with CEFET on 24 September.

Oct 09: One EM, jointly hosts with EMEL, EMCF, SEEM and REM, workshop on a Flourishing Region. EMRIC develops delivery plans for Commissioning and Strategic Influence pilot projects.

Nov 09: Skyers-Poorman, consultants work on health priorities for One EM, running two workshops on 18 and 20 November to launch Health Network and identify health inequalities for future focus. Funding submission for European Year for Combating Poverty and Social Exclusion 2010 events submitted by One EM, CEFET and the EM Financial Inclusion Champion.

Dec 09: Michelle Payne starts work as Development Manager and Henry Muchiyani as Policy Analyst. East Midlands Infrastructure Finder successfully transfers from EMI to One EM website. Coordinated response to Social Care Green Paper to the Department of Health.

Jan 10: Awarded £9,462 from CapacityBuilders Capital Investment Fund for online resources and meeting facilities.

Feb 10: Partnership Conference on Health successfully takes place on 25 February. Case studies brochure printed and distributed to members to celebrate first anniversary or launch the One EM membership scheme. Membership survey sent out to members seeking information on members' services.

Mar 10: Two video case studies filmed featuring Ticknall Lunch Club with South Derbyshire CVS, and Northampton Volunteering Centre with Zimwomen Association.

Organisation restructure

One EM's organisational restructure was completed in 2009/2010 with the creation of two senior management positions, completing the senior management team. Hannah Luck was promoted to Communications Manager and Michele Payne was appointed as Development Manager.

The following figures are taken from the report and accounts of One East Midlands for the year ended 31 March 2010.


During the year, One EM's income was £232,492 and expenditure was £295,983, leaving a net loss of £63,491 utilising restricted funds carried forward from 2008/9. The pie charts give a breakdown of the principal sources of income and how funds were spent during the year.

At year end, One EM's reserves were £128,066. Of this, £22,026 were restricted funds and £106,040 were in general reserves.


Accountability
