SURVEY : ANNEX A

This survey was distributed by One East Midlands to the EMFAN members and those listed on its database. The survey was created on 11 March and open for responses until 14 May. The target response was 50 but despite circulating the request several times over a period of , only 39 people responded but those who did respond were from a variety of roles and organisations from across the East Midlands and therefore their responses are helpful as part of the overall evaluation. The following are the responses to the questions with some interpretation.

QUESTION 1

What is your job title?

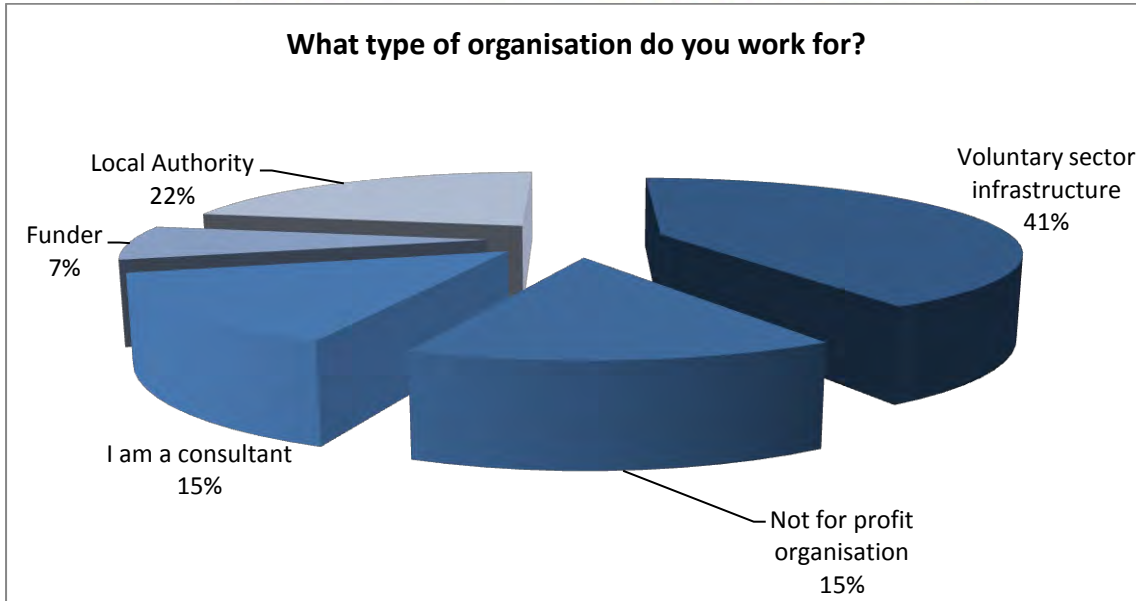
The online survey was completed by 39 people only six of whom had a job which explicitly involved funding advice. The majority of respondents were project officers, policy officers, business managers, community development workers etc from a mix of third and public sector organisations. Question two sets out the range of organisations that responded.

Question 2

What type of organisation do you work for?

The answers to this question would suggest that the project has been successful in reaching the target audiences identified at the initial stage and that although the primary beneficiaries have been people offering funding advice from within the Voluntary Sector Infrastructure there has also been a strong connection with front line groups, local authorities and funders as well as private consultants offering funding advice.

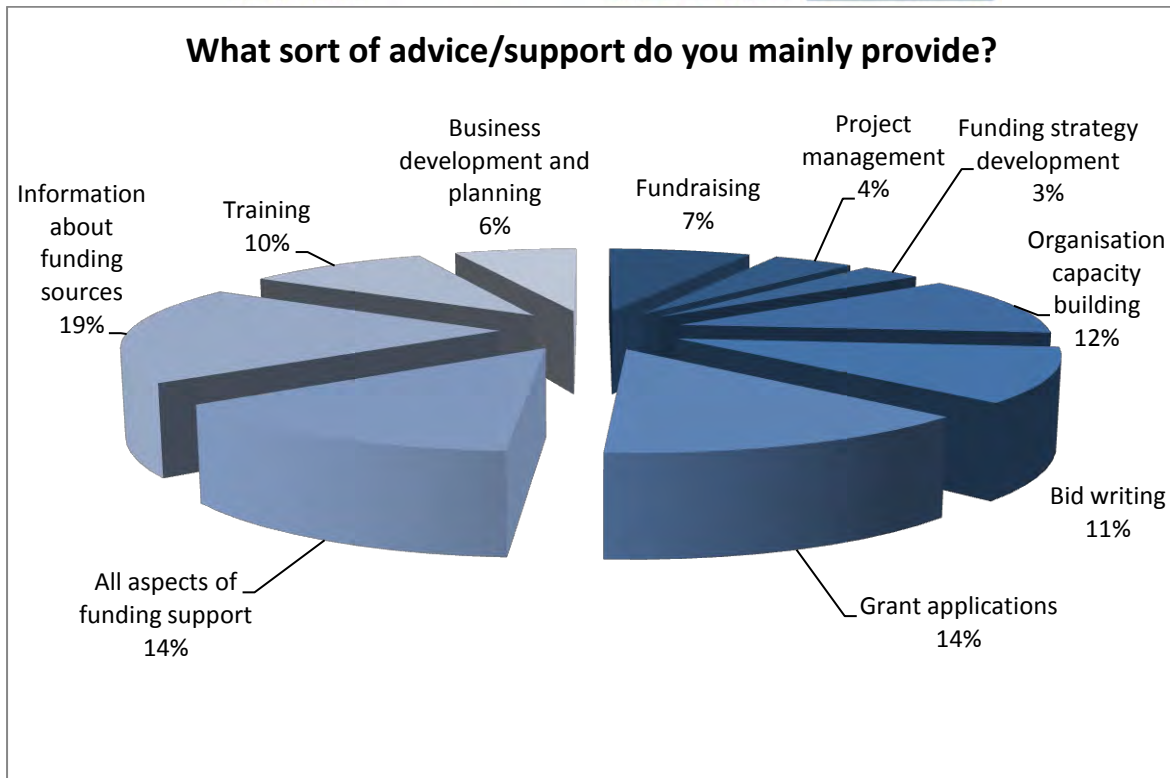


Question 3

What sort of support/advice do you mainly provide? (tick the two most important that apply)

Two of those who answered 'other' are local authority/district council grant funders. Others were offering advice about specific issues (e.g. fundraising around a particular health issue or working with a particular target group), two were offering professional support round commissioning or project management.

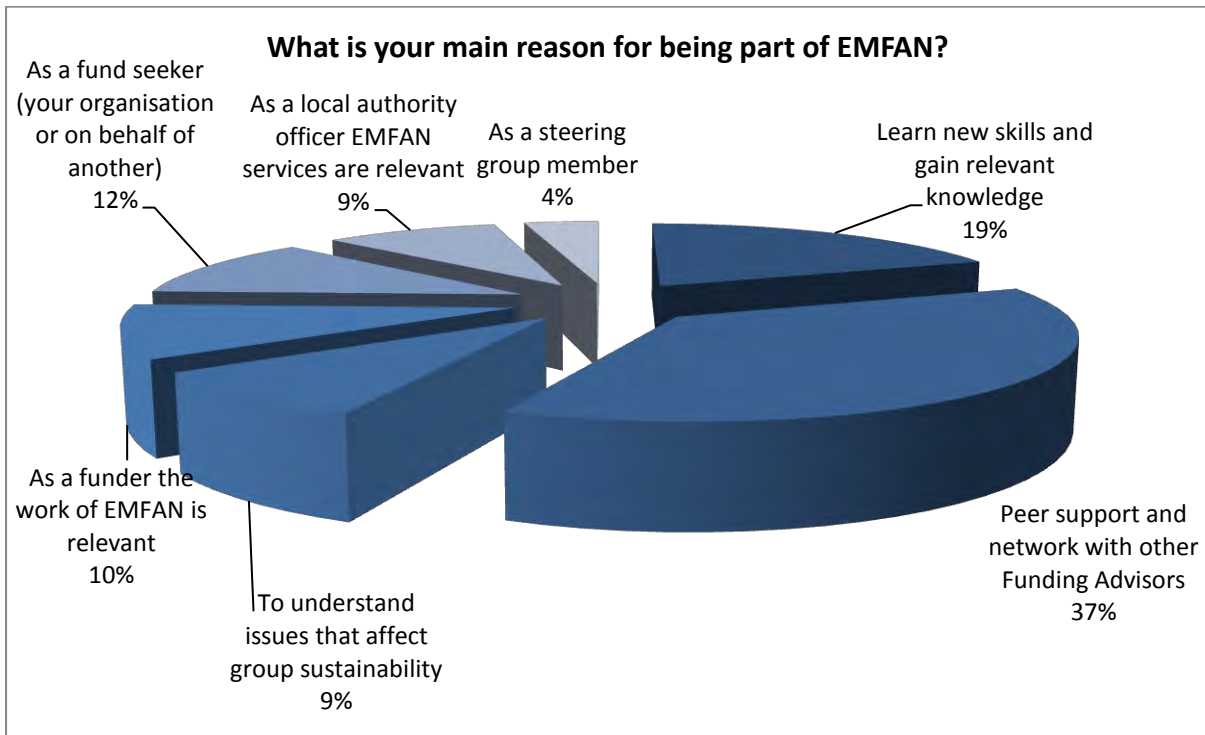


Question 4

The answers to this question clearly show that for the majority peer support and networking is the most significant benefits arising from EMFAN. There is also a good spread of organisations which find the network useful – funders as well as fund seekers which suggests that the project has been successful in reaching its target group.

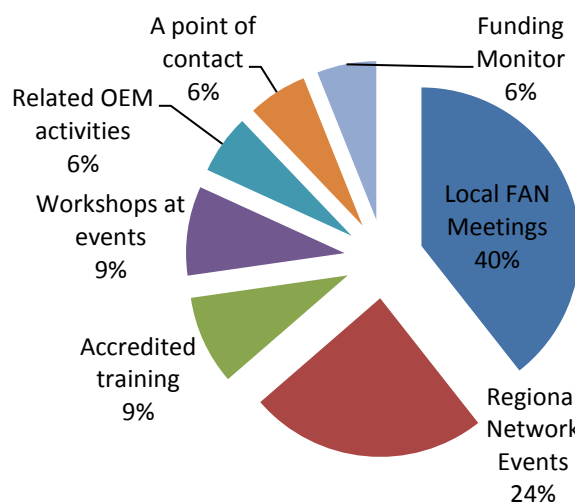

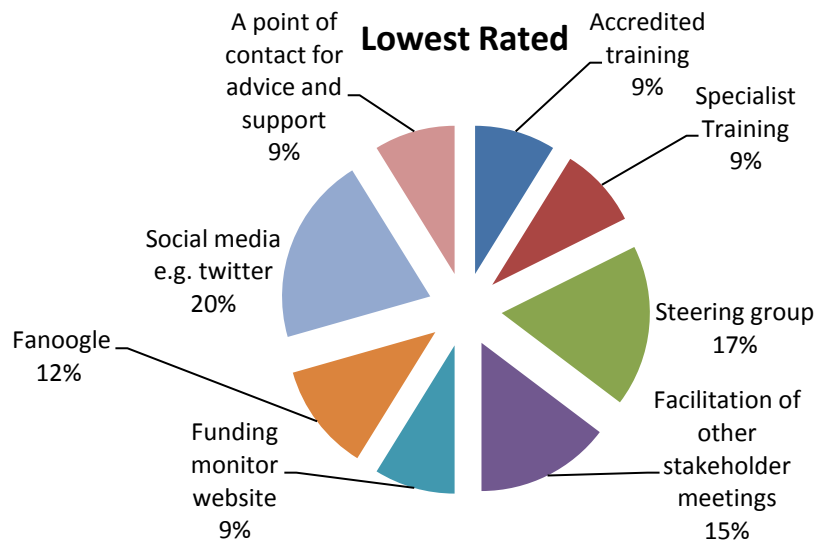
Question 5

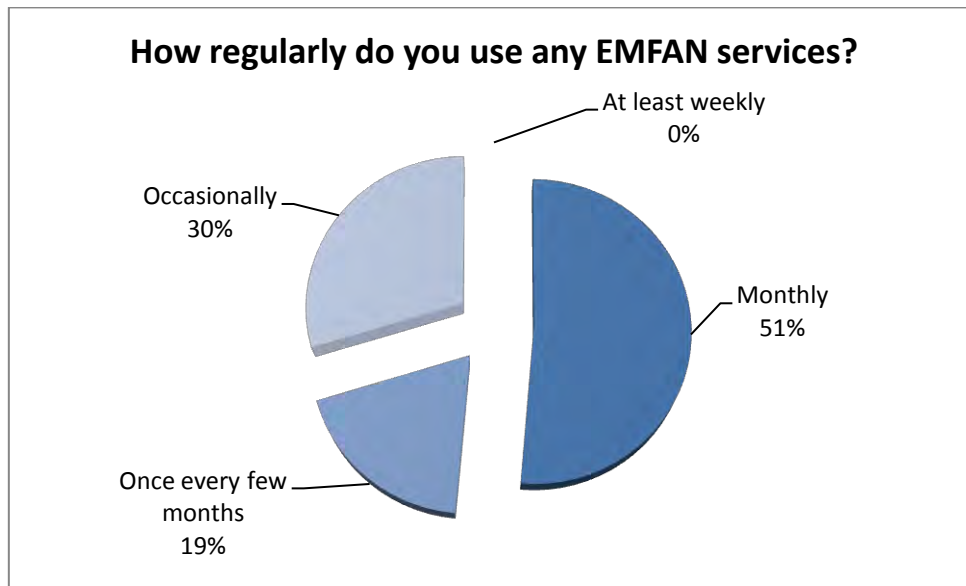


People ranked the following services least highly

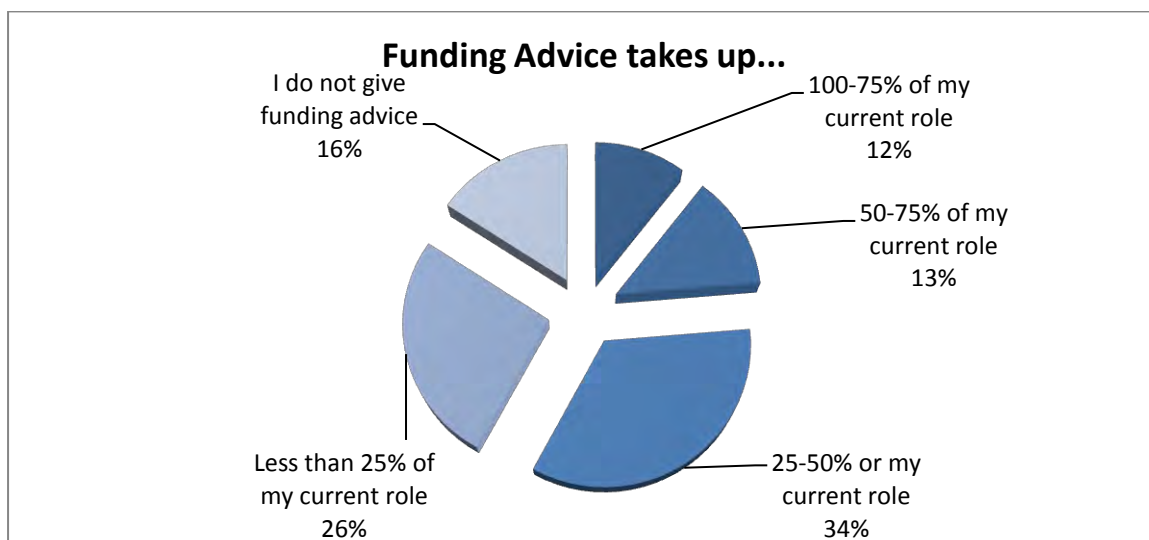
How regularly do you use any of these EMFAN services?

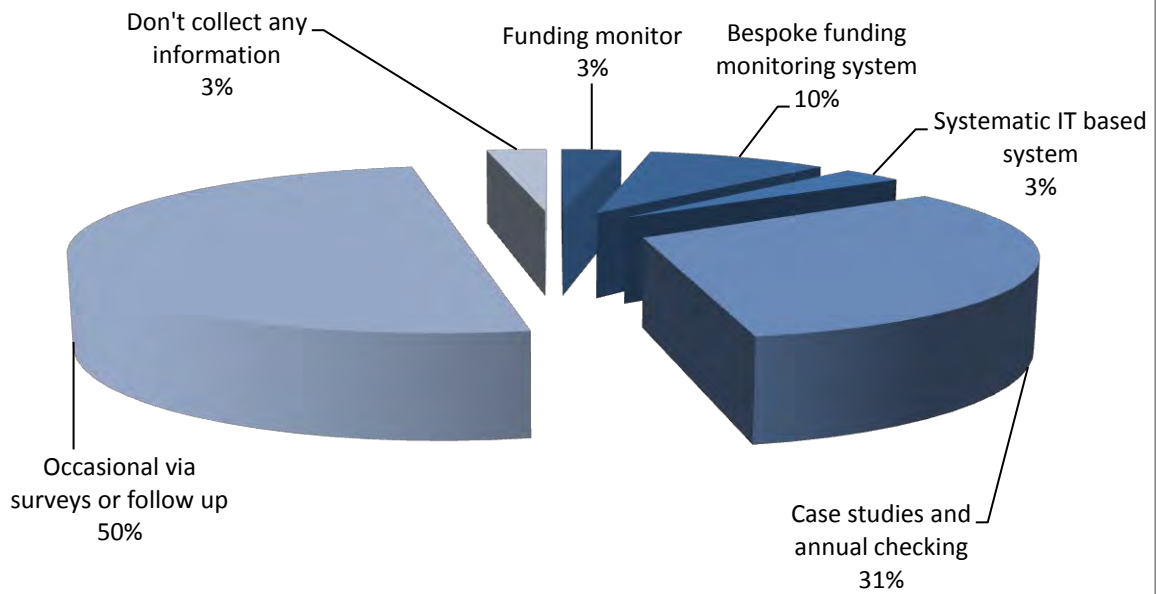
Question 8

How do you track successful funding advice outcomes for beneficiaries?



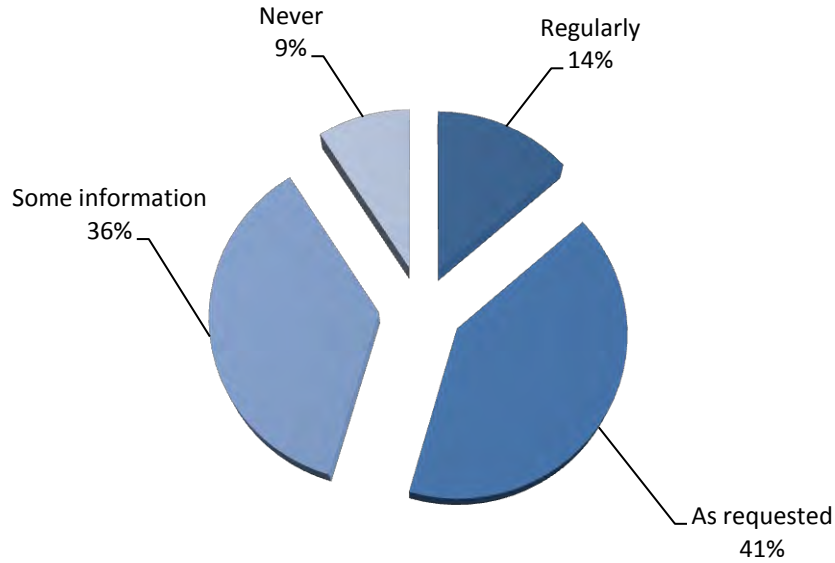
Question 9

Do you share funding success information with other stakeholders including EMFAN?

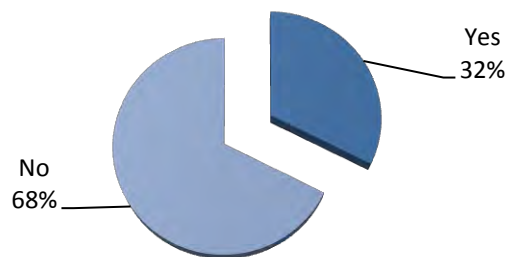

Although the response rate is low with only 12 of the respondents having attended training, the response tallies with the feedback from the course and event evaluations and show that the project has resulted in funding advisors acquiring knowledge and skills.

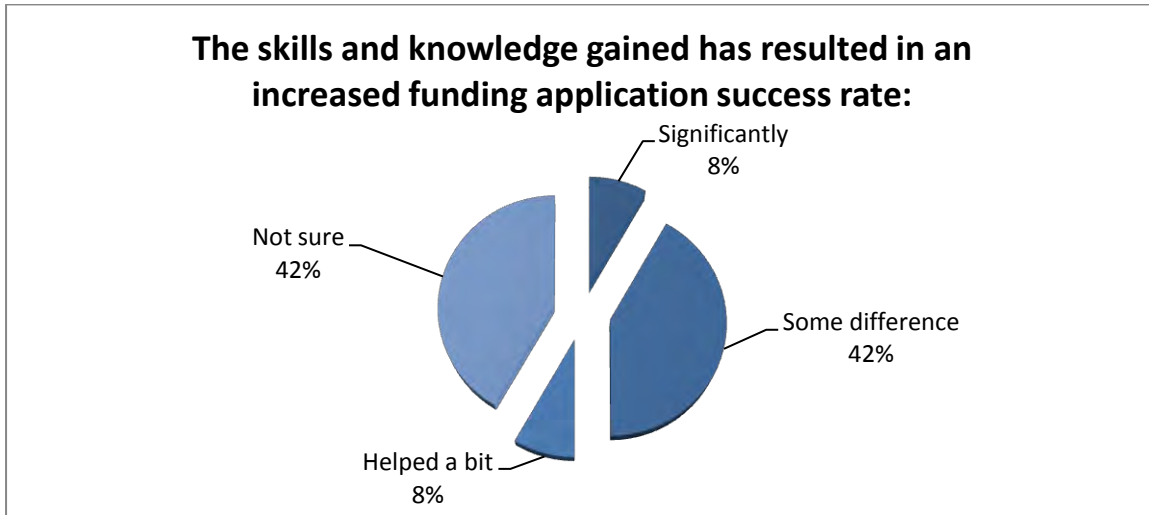
Question 13

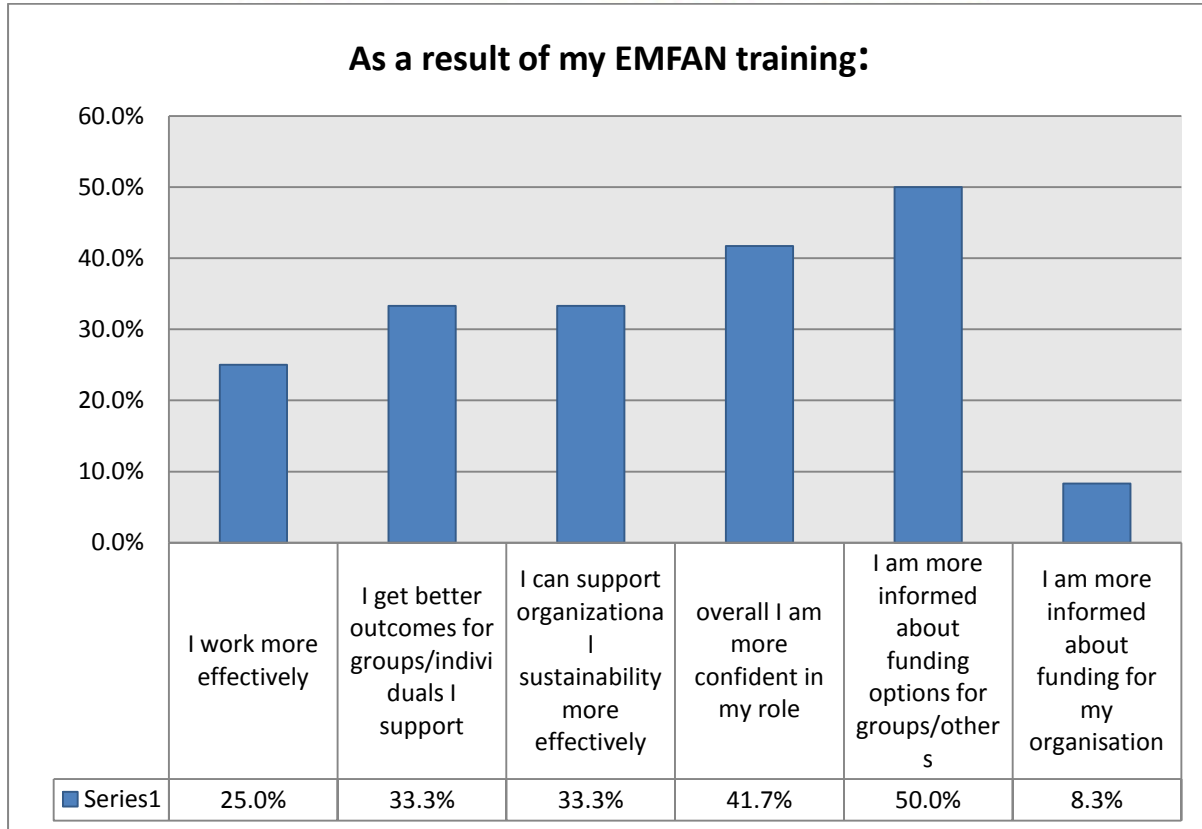


Question 14

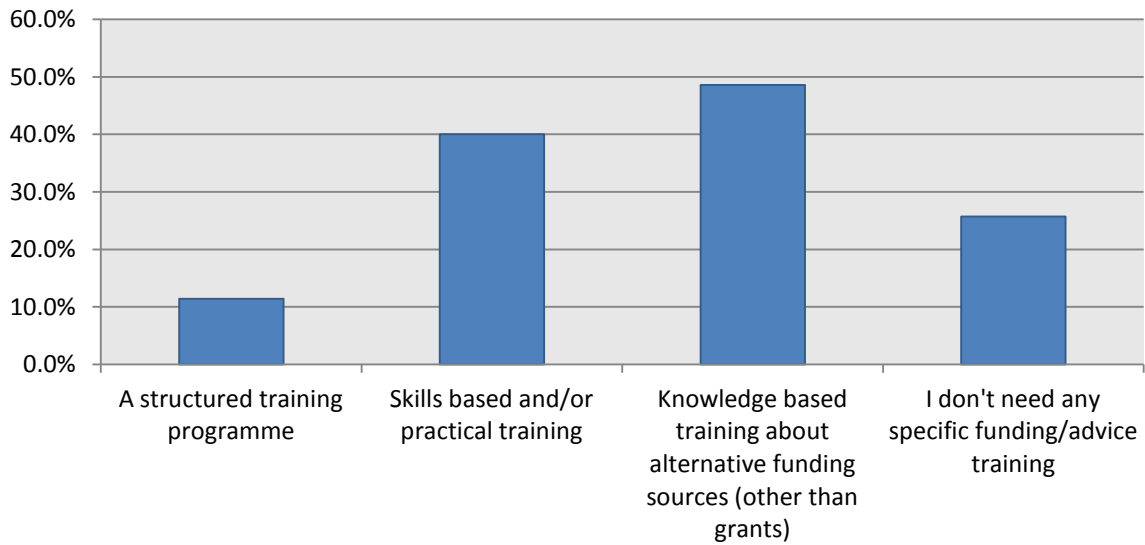
Question 15

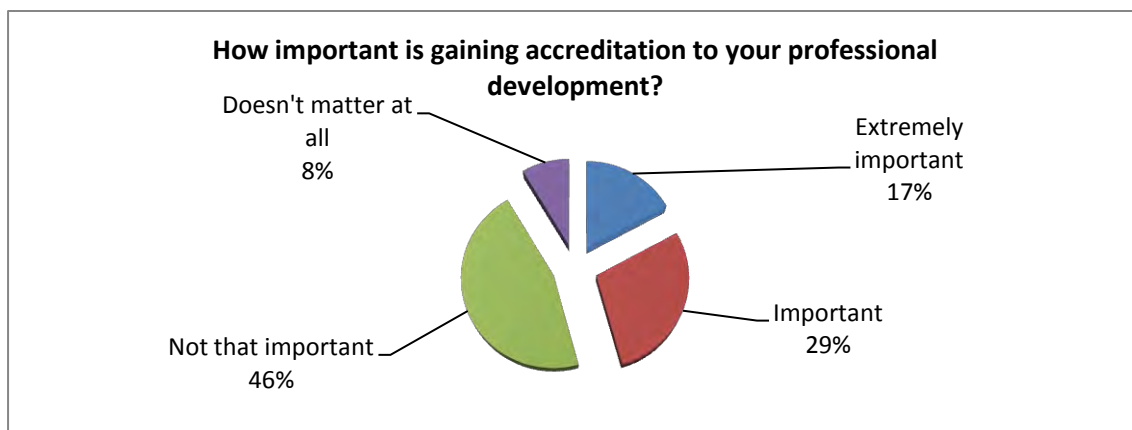

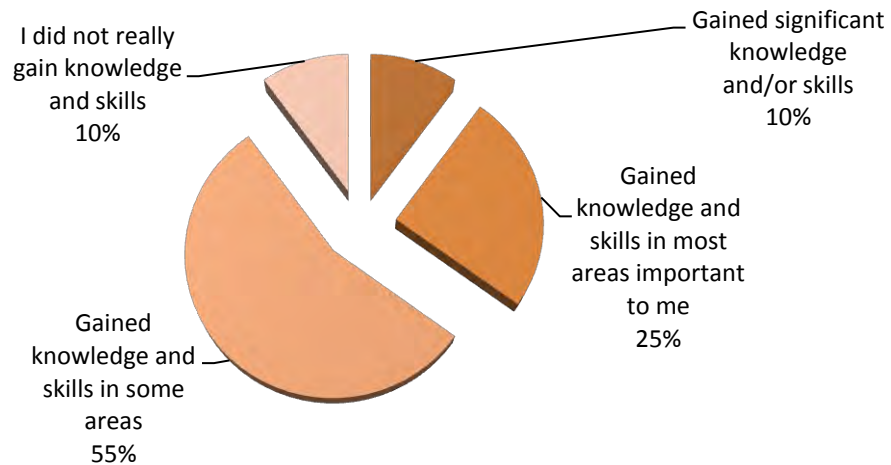

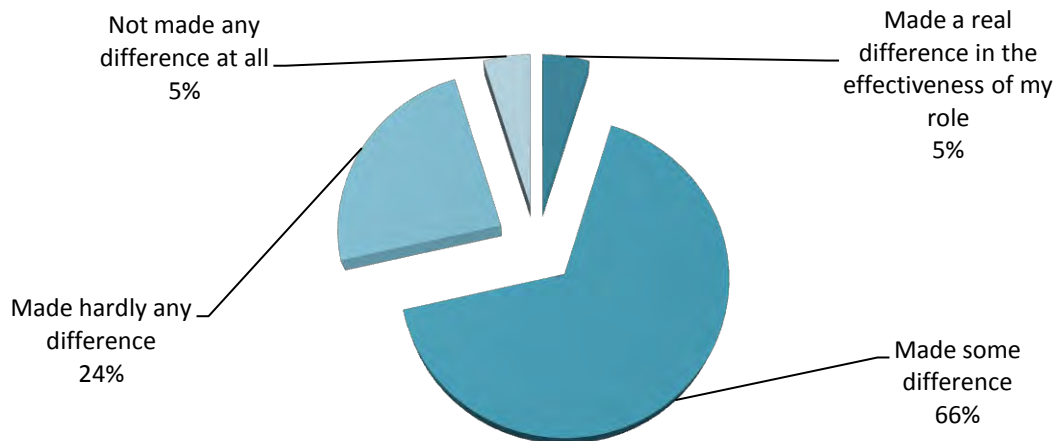

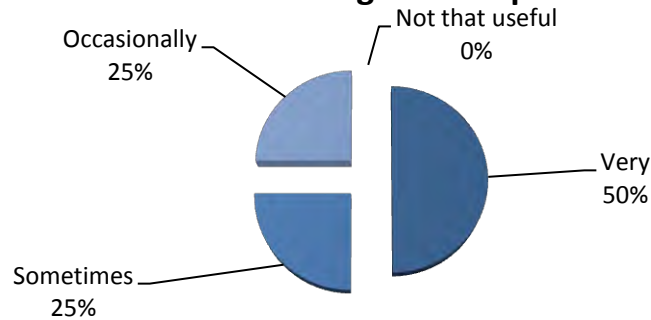
Question 26

27 people answered this question and there was a very diverse range of answers. Funding Central and the Big Lottery were two sources of information mentioned regularly. Others use newsletters – either from OEM or other local infrastructure - County Council sources or search engines.

Question 29

List up to 3 issues that you think are relevant to the future of Funding Advice.

25 people answered this question and gave very diverse responses but the following were some key themes

Information –staying up to date and informed about changes affecting the sector such as Social Value and Social finance

Information. Getting information about funding opportunities – in particular new funding streams such as European Funding

Commercial awareness – business planning, charging for services, contracts and tendering, project management etc

Better use of **online opportunities** such as webinars, skype etc.

Training and development – support with issues such as governance, gift aid.

Connecting - meeting each other and funders to learn from each other

Quality –sharing information about what advice has been successful and what works

Impartial and independent **one-to-one support**
