## Empowerment Funding

### £30million funding for local communities

Two new sources of funding have been announced for communities, worth a total of £30million. The £19million Community Ownership of Assets programme offers grants to communities wanting to take control of a local asset such as a pub, shop, or library. The programme is part of the Community Right to Bid, which comes into force in the autumn.

The Community Right to Challenge, which has recently become law, has £11million of grants available to communities with ideas about how they can run a local service. The grants programme is provided by the Social Investment Business. ### Cooperative Community Fund

The Co-Community Fund provides grants of £100 and £2,000 are awarded to community groups to cover everything from equipment to event costs, help towards rent or fixtures, sport and computer equipment. The Cabe team will work with community groups to tailor a support package of hands-on expert help, using their pool of architects, planners, urban designers, landscape architects and those with community involvement experience to provide the expertise needed.

Help can include exploring potential, delivering training, providing technical expertise, reviewing documents produced, helping to overcome sticking points or advising on writing briefs, visions and plans.

The deadline for applications is 5pm on Monday 20 August, with the free support provided between September 2012 and March 2013. ### Designing a Community Website

Software company Serif has producing a list of five dos and don'ts for creating community websites, which are:

- Do include valuable content - Design your site around your content and, before you start designing, ensure the content is concise, will interest visitors and hold their attention.
- Don't distract visitors - Keep things as simple as possible and make it clear where you want your customer to click next.
- Do make your website easy to read - Let your content to do the talking and don't make it difficult to digest. Keep sentences and paragraphs short. Stick to Arial, Tahoma, or Verdana fonts.
- Do make it easy to navigate - Keep pages structured, consistent and uncluttered, with menus in a fixed place throughout a site and images aligned with text for example.
- Do think about SEO in the design phase - Incorporate search engine optimisation into the design process.
